I - Introduction

On the third day of May two thousand and twenty-two, at 14:00 hours and 30 minutes, the jury nominated by the CCMAR board of Directors on 02/03/2022, met by video conference, for the meeting 3 of the call Ref. CCMAR/BIC/08/2022. The meeting was held for the award of 1 Research Fellowships (Scientific Initiation Fellowship – BIC) through the research project MARAFRICA "*A network monitoring, integrating and assessing marine biodiversity data along the west Africa to understand, predict and mitigate climatic / oceanographic changes.*" reference no 540316524 funded by Aga Khan, Network for Development and the Portuguese Foundation for Science and Technology, I.P.. The jury, included Professor Ester Serrão, Professor at Algarve University, coordinator of the project at CCMAR and researcher and team leader at CCMAR (President); Professor Karim Erzini, Professor at Algarve University and researcher and team leader at CCMAR (member); Professor Alexandra Teodósio, Vice- Rector at Algarve University and researcher and team leader at CCMAR (member) and had the following agenda items: decision about the final results following the end of the right of prior hearing of the candidates.

II – Claims

After the communication of the provisional results on April 14th 2022, an email was received from Gabriela Fernandes on April 18th 20:24. The candidate has asked why she was not selected and if more feedback could be given. The president of the jury has replied to the candidate and explain her the reasons why she was not selected. No more claims were received during the period of prior hearing of the candidates.
