I - Introduction

On the sixth day of December two thousand and twenty two, at ten hours, the jury nominated by CCMAR board of Directors on 02/09/2022, met by videoconferce, for the second meeting of the call Ref. CCMAR/BINCGAM/26/2022. The meeting was held for the award of a Research Fellowship for a Person with a Master Degree (Bolsa de Investigação não conducente a grau aacadémico para mestre) through the project with reference **CIRCNA/BRB/0156/2019**, named as A-Fish-DNA-Scan *“Cutting-edge DNA-based approaches for improved monitoring and management of fisheries resources along Magellan-Elcano’s Atlantic route”* (“Abordagens avançadas baseadas em ADN no apoio à monitorização e gestão de recursos pesqueiros ao longo da rota Atlântica de Magalhães-Elcano”) funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funding (PIDDAC). The nominated jury was composed by Dr. A. Miguel Santos, responsible of the project at CCMAR and researcher at IPMA and CCMAR (president of the jury), Professor Maria Alexandra Anica Teodósio, Vice-Rector at Algarve University and researcher at CCMAR (Member) and Professor Joana Cruz, Invited Assistant Professor at UALG (member) and had the following agenda: (i) admission and evaluation of applications admitted to the fellowship CCMAR/BINCGAM/26/2022.

II – Candidates

Seven applications were received for the position:

3. Gabriela de Souza Fernandes
4. Anna Thomasdotter
5. Inês Sofia Régio Pereira
6. Inês Caseiro Dias
7. Patricia Alcázar González

III - Exclusion of applications

The jury analysed the applications, considering the mandatory documents, and decided to exclude the candidate Gabriela de Souza Fernandes because she did not finished her Master

degree yet. Thus, six candidate were admitted to evaluation (Table 1).

IV - Evaluation of applications

The Jury evaluated the application documents of the eligible candidates (Table 1) and applied the classification criteria and weighting factors set out in the vacancy announcement as shown in Table 2 below.

Evaluation criteria and respective weighting:

- 1) CV, including publication record (50%)
- 2) Experience in sampling and identification of ichthyoplankton (30%)
- 3) Training in Next-generation sequencing for environmental monitoring (10%)
- 4) Fluency in English, with good communication skills (oral and written) (10%)

Note: The final grades in Table 3 represent the average of the individual evaluation performed by each member of the jury, presented on a scale from 0 to 20, rounded to the nearest tenth.

The overall classifications in order of rank are presented in Table 3 below.

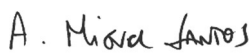
V - Conclusion

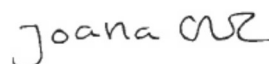
