Out of interest, I would like to get more information about the compilation of the score. If collaborations in published articles are included please take into account the research output of project Operation Posidonia listed in my CV (DOI: 10.1016/j.biocon.2021.109308.)

I apologize for the inconvenience and thank you,

III - CONCLUSION

Concluded the period of prior hearing of the candidates candidate Javier Jimenez requested clarification on the criterion 4 (Published scientific articles). The jury included here scientific contributions such as the candidate his contribution to a conference presentation and that is why his score despite not being co-author on a publication did receive a score. Although Javier might have contributed to the by him mentioned publication, he is not a co-author nor is he

listed in the acknowledgements for contributing. As such we can not give him a higher score on criterion 4. We acknowledge that he is a very good candidate for a project as Blueforest.

The selection committee remains unanimous with the provisional decisions taken in minute 2. In accordance with the presented elements the candidate Hannah Julia van Duijnhoven meets the conditions for selection. For this reason the selection committee proposes to the CCMAR board of Directors the approval of this decision.
